1	Preliminary Scrutiny of the proposals	Preliminary scrutiny of all the applications received under the Scheme of Financial Assistance for Promotion of Guru-Shishya Parampara (Repertory Grant), every year, will be done by National School of Drama, New Delhi	Preliminary scrutiny of all the applications (including the applications of organizations associated with ECM Members/Padma & SNA Awardees) received under the Scheme of Financial Assistance for Promotion of Guru-Shishya Parampara (Repertory Grant), every year, will henceforth be done in the Performing Arts (P. Arts) Division of the Ministry.
2.	Mode of Selection	There will be personal interaction for renewal of Financial Assistance for Promotion of Guru-Shishya Parampara (Repertory Grant) proposals.	There will be no personal interaction for renewal of Financial Assistance for Promotion of Guru-Shishya Parampara (Repertory Grant) proposals. All the query(ies)/ clarification(s)/ justification(s), if any, will be sought via email/ phone/ Video conferencing.
3.	Eligibility and Criteria for Grant	Physical verification would be compulsory for continuation of Financial Assistance for Promotion of Guru-Shishya Parampara (Repertory Grant) after every 4th (fourth) year.	Only 10% of renewal cases will be subject to physical inspection in a year. Such organizations for verification will be shortlisted by the Ministry on the basis of following major criteria:  a) The number of Shishyas b) Frequent changes in the name of Shishyas by the grantee organization c) Organizations which are over-represented in particular art form d) Organizations not inspected in last 5 years e) Organizations having common office bearers/ run by close family members

4.		As regards the fresh cases of Financial Assistance for Promotion of Guru - Shishya Parampara (Repertory Grant), the approved grant in each case shall be released only after a physical verification of the Organizations as decided by the Ministry. Further, a minimum 5-10% of new recommended proposals/ cases would be physically inspected / verified by the Officers concerned in Ministry of Culture.	All the provisionally approved new applications will be physically inspected by the Ministry of Culture with recorded photo/video evidence and Geo-location.
5.	Documents to be submitted with the Application	Complete details of Guru/Director and Shishya/Artists enrolled with the organisation for which financial assistance is sought along with their respective bank account details.	While furnishing the details of Guru/Director, the Organisation needs to categorically mention whether the Guru/Director is claiming/not claiming the grant from the organisation under the scheme.
		Exemption would be given to the Padma awardees from getting the recommendation from concerned State Governments/UT Administrations or any of the State Akademies or National Akademies including National School of Drama, Kalakshetra Foundation, Centre for Cultural Resources and Training, Indira Gandhi National Centre for the Arts (IGNCA), Zonal Cultural Centres and bodies of similar nature.	All the organizations, including those associated with Padma Awardees, are required to furnish the recommendation from concerned State Governments/UT Administrations or any of the State Akademies or National Akademies including Sangeet Natak Akademie, National School of Drama, Kalakshetra Foundation, Centre for Cultural Resources and Training, Indira Gandhi National Centre for the Arts (IGNCA), Zonal Cultural Centres and bodies of similar nature.
