Minutes of the meeting of Steering Committee held on 02.11.2023 under the Scheme Component of 'Financial Assistance to Cultural Organizations with National Presence' under "Scheme of Financial Assistance for Promotion of Art & Culture" for the year 2022-2023.

A meeting of the Steering Committee was held on 02.11.2023 under the Chairpersonship of Shri Kishore K. Basa, Director General, Archeological Survey of India at Board Room, Dharohar Bhawan, Tilak Lane, New Delhi to examine the proposals in detail and to decide the quantum of financial assistance to deserving organizations under the scheme component of 'Financial Assistance to Cultural Organizations with National Presence' for the year 2022-2023. List of participants of the meeting is given below:

- (i) Shri Kishore K. Basa, Director General (Archeological Survey of India), & Chairperson;
- (ii) Ms. Amita Prasad Sarbhai, Joint Secretary (P. Arts Bureau), MoC& Member;

- 2. At the outset Ms. Amita Prasad Sarbhai, JS (P. Arts Bureau), MoC welcomed Chairperson and all the members of the Committee and gave a brief outline of the Scheme component, eligibility criteria and its relevant guidelines.
- 3. The Committee then examined the proposals submitted by the organizations, taking into account the profile of the organization, subject of proposed project, duration of the project, estimated cost of the project and amount sought from the Ministry. Further, the Committee also noted the expenditure incurred by the organization/trust on cultural activities during three years out of the last five years and activities undertaken by the organization. 4. While deciding the financial assistance to the eligible organizations, the Committee took into consideration the criterion laiddown in the scheme guidelines such as whether the organization has spent ₹1 crore or more during three of the last five years on cultural activities, the organization has capacity to do at least 20 events/programmes in a year, etc. The committee also noted that many applicant organizations were already existing recipients of grants such as Repertory Grant, Cultural Function & Production Grant, etc. administered by the Ministry of Culture. The Committee further noted that the project brief as well as estimated cost of some of the organizations was similar to each other.
