Minutes of the meeting of the Expert Committee held on 26th & 27th Sept. 2018 in National School of Drama, New Delhi under the Scheme subcomponent of 'Financial Assistance for Cultural Activities in Performing Arts for Building Grants Including Studio Theatres' under "Scheme of Financial Assistance for Creation of Cultural Infrastructure".

A meeting of the Expert Committee under the Scheme sub-component of 'Financial Assistance for Cultural Activities in Performing Arts for Building Grants Including Studio Theatres' was held under the Chairpersonship of Shri Padma Lochan Sahu, Joint Sectretary (Z), Ministry of Culture during 26th & 27th Sept. 2018 at National School of Drama, New Delhi to consider proposals received from various organizations for financial assistance under the said Scheme sub-component. The list of expert members present in the meeting is at Annexure-III.

- 2. The Chairperson welcomed all the members of the Committee and briefed them about the salient features of various provisions of the Building Grant Scheme sub-component under which the proposals included in the agenda were required to be examined by the Expert Committee members. The Chairperson emphasized to examine the proposals scrupulously in terms of the guidelines of the Scheme sub-component vis-a-vis allocated budget for said sub-component.
- 3. The Expert Committee considered and examined each proposal individually before taking a decision and recommended 26 proposals for financial assistance under the scheme, details of which are given at Annexure-I. The list of 38 proposals not recommended by the Expert Committee is indicated at Annexure-II.
