I am directed to say that Ministry of Culture provides financial support to NGOs for undertaking various programmes for propagation and scientific development of Buddhist/Tibetan Culture /tradition etc.

2. As per para 4.2 of the scheme guidelines, the proposals from NGOs are to be recommended by the State Govt. However, in view of the far flung locations of Leh and Kargil Distt. of Jammu & Kashmir, the North Eastern States & Sikkim, the Distt. Collector/Deputy Commissioners are empowered to recommend the proposal & send to the Ministry directly. The respective States may, therefore, further circulate it to their respective District Collectors. Further as per para 4.2, the recommending authority has to verify certain facts & to recommend the activity/activities and the amount thereto.

A copy of the advertisement has been uploaded on the website of the Ministry. The guidelines etc. are also available on Ministry of Culture's website, i.e. www.indiaculture.nic.in.

4. You are, therefore, requested to take suitable action for recommending the deserving proposals as per format given in para 4.2 of the scheme so as to reach the same in the Ministry, by stipulated date.
