Minutes of the meeting of Steering Committee held on 29.05.2020 under the Scheme Component of 'Financial Assistance to Cultural Organizations with National Presence' under "Scheme of Financial Assistance for Promotion of Art & Culture" for the year 2019-20.

A meeting of the Steering Committee was held on 29.05.2020 at 11:00 AM under the Chairpersonship of Shri R.K. Chaturvedi, Special Secretary & Financial Advisor, MoC at Shastri Bhawan, New Delhi to examine the proposals in detail and to decide the quantum of financial assistance to deserving organizations under the scheme component of 'Financial Assistance to Cultural Organizations with National Presence' under "Scheme of Financial Assistance for Promotion of Art & Culture" for the year 2019-20. The following Officers/Members attended the meeting:-

- (i) Shri R.K. Chaturvedi, Special Secretary & Financial Advisor, MoC & Chairman;
- (ii) Ms. Amita Prasad Sarbhai, Joint Secretary (P. Arts), MoC & Member;
- (iii) Dr. (Smt.) Rita Swami Choudhary, Director, Sangeet Natak Akademi & Member;
- (iv) Shri Suresh Sharma, Director-in-charge, National School of Drama & Member; and
- (v) Ms. Deepika Pokharna, Director (P. Arts), MoC & Member Secretary.
- 2. At the outset the Chairperson of the Steering Committee i.e. Special Secretary & Financial Advisor, MoC welcomed all the members of the Committee and JS(P.Arts) gave a brief outline of the Scheme component, eligibility criteria and its relevant guidelines.
- 3. The Committee then examined the proposals submitted by the organizations after taking into account the profile of the organisation, subject of proposed project, duration of the project, estimated cost of the project and amount sought from the Ministry, expenditure done by the organisation/trust on cultural activities during three years out of the last five years and activities undertaken by the organisation. Analysis and recommendations of the Committee are placed at Annexure 'A'.
- 4. While deciding the financial assistance to the eligible organizations, the Committee took into consideration the criteria laid in the scheme guidelines eg. the organization has spent Rs.1 crore or more during three of the last five years on cultural activities, the organization has capacity to do at least 20 events/programmes in a year, etc. The Committee also noted that many applicants were already existing recipients of grants under one or more scheme administered by Ministry of Culture. The Committee further noted that the project brief as well as estimated cost of few of the organizations were similar to each other.
- 5. Out of the 40 proposals (at Annexure 'A') received in response to the advertisement, only 33 were received within the last date of submission i.e. 23rd March, 2020. However, the 07 proposals received after due date were also put up to the Steering Committee considering the lockdown situation due to Covid-19.
- 6. The Committee after careful deliberation and due consideration of the documents submitted by the applicants has recommended the financial assistance to the undermentioned organizations as per details given below, subject to the condition that the organizations will recognize the assistance being provided by the Ministry by appropriately displaying the name of Ministry of Culture as co-partner of the
