**MINUTES OF 34<sup>th</sup> MEETING OF THE CULTURAL FUNCTION AND PRODUCTION GRANT SCHEME (CFPGS) HELD ON 27<sup>th</sup> to 28<sup>th</sup> March 2017 AT NSD, New Delhi**

Under CFPGS Scheme Financial Assistance is given to 'Not-for-Profit' Organisations, NGOs including Societies, Trust, Universities and Individuals for holding Conferences, Seminar, Workshops, Festivals, Exhibitions, Production of Dance, Drama-Theatre, Music and undertaking small research projects etc. on any art forms/important cultural matters relating to different aspects of Indian Culture. The quantum of assistance is restricted to 75% of the project cost subject to maximum of Rs. 5 Lakhs per project as recommend by the Expert Committee. In exceptional circumstances Financial Assistance may be given upto Rs. 20 Lakhs with the approval of Hon'ble Minister of Culture.

2. A meeting of CFPGS was held on 27<sup>th</sup> to 28<sup>th</sup> March 2017 under the Chairmanship of Shri M.L. Srivastava, Joint Secretary to consider the proposal for financial assistance by the Expert Committee.
