

Minutes of the meeting of the Expert Committee held on 21st & 22nd Sept, 2017 in National School of Drama, New Delhi under the Scheme of Building Grants, including Studio Theatres.

A meeting of the Expert Committee under the Scheme of Building Grants including Studio Theatre was held under the Chairpersonship of Ms. Sujata Prasad, Additional Secretary, Ministry of Culture during 21st & 22nd Sept. 2017 at National School of Drama, New Delhi to consider proposals received from various organizations for financial assistance under the Scheme. The list of expert members present in the meeting is as Annexure.

2. At the outset Chairperson welcomed all the members of the committee and briefed them about the salient features of various provisions of the Building Grant Scheme under which the proposals included in the agenda were required to be examined by the Expert Committee members. The Chairman emphasized to examine the proposals scrupulously in terms of the guidelines of the Scheme.

3. The expert Committee considered and examined each proposal individually before taking a decision and recommended the following 39 proposals for financial assistance under the scheme:-

The Committee also observed that despite uploading the status of deficient proposals/applications on the web page of NSD, Delhi and requesting the concerned organisations to remove the deficiencies by submitting the requisite papers/documents, several applications/proposals are still found to be incomplete. Therefore, it has been recommended that all such applications/proposals stand not recommended and all such applicant organisations are required to submit fresh applications if they want to consider their proposal in future.
