2. Interest earned of Rs. 2,59,019/- on previous installment is being adjusted from this installment of grant.

3. The grant will be subject to the terms and conditions as stipulated below:-

(i) The audited accounts and utilization certificates in respect of the grant to the effect that the grant has been utilized for the purpose for which it was sanctioned duly signed by Chartered Accountant should be furnished to this office within 12 months of the closure of the financial year of the release of this installment covering the matching share of the organization also, failing which the organization is required to refund the amount already drawn under the scheme, to the Ministry of Culture, New Delhi with a penal interest of 10% per annum.

(ii) The grant will be drawn by the Drawing & Disbursing Officer, Ministry of Culture and paid to **Netaji Research Bureau, Netaji Bhawan, Kolkata** by means of Electronic Transfer to their A/c No. **33210018528** at **Standard Chartered Bank, Branch of 41, Chowringhee Road, Kolkata.**

(iii) Misutilization of funds or non-submission of UC in time will be viewed seriously and the defaulter organization will be black listed and debarred from receiving future grants from Govt. of India, as well as appropriate action under the law would also be taken by the Government.

(iv) It is certified that no Utilization Certificate is pending in respect of previous grant/grant(s).

(v) It is certified that the grantee has fully utilized the 1<sup>st</sup> and 2<sup>nd</sup> installment released by the Central Government as well as their proportionate matching contribution.

(vi) The expenditure will met from Demand No. 18, Ministry of Culture, Major Head 2205, Minor Head 00.107- 41, Development of Museums – Museum Schemes - 01.35 - Grants for Creation of Capital Assets (Revenue) Non-recurring for the year 2018-2019.

(vii) This sanction is issued in exercise of the delegated powers and in consultation with AS & FA vides their **Dy. No 10972** dated **12.07.2018**. It is certified that the pattern of assistance under the above scheme has the prior approval of the Ministry of Finance, Government of India. It is certified that this grant is being released in conformity with the rules and the principles of the scheme.


