Subject:- Furnishing of documents for release of Repertory Grant for the year 2021-2022 and 2022-2023- regarding.

The Ministry of Culture is in process to release the Repertory Grant under Guru-Shishya Parampara for the year 2021-2022 and 2022-2023. As many grantee organizations might have made the payment from their own sources to their Guru & Artists therefore grant will be released to these organizations on reimbursement basis. Grantee Organizations seeking the repertory grant on reimbursement basis for the year 2021-2022 and 2022-2023 are requested to provide the following papers/documents immediately:-

a) Documentary proof of the payment of honorarium that has already been made by the grantee organizations to their Guru & Artistes for the year 2021-2022 and 2022-2023 for which grant is being claimed from Ministry viz. Bank statement for said period, duly countersigned by the Bank Manager.

b) Audited Statement of Accounts (Receipt & Payment, Income & Expenditure and Balance Sheet] duly certified by Chartered Accountant (C.A.) with clear mentioning therein the period for which grant received from the Ministry, if any, or source of funds through which honorarium has been paid to the Guru and Artistes with complete details viz. name of Guru & Artists, period for which payment is made and amount paid to them. If the details of Guru/Artists and period are not mentioned in the Audited Statement of Accounts already submitted by the organizations, the organization shall have to submit a supplementary accounts statement certified by C.A. showing complete details viz. source of funds, name of Guru & artists along with copy of their Aadhar Card, period for which payment made, and amount paid to them.

2. In case where Grantee Organizations are yet to make payments to Guru and Artists for the year 2021-2022 and 2022-2023, payment will be released to such grantee organizations through Central Nodal Agency (CNA) i.e. National School of Drama. In these cases the grantee organizations are requested to send the duly filled complete details of Guru & approved number of Artists in downloadable excel format of DBT proforma (Annexure-II) available on the website of this Ministry i.e.<u>https://www.indiaculture.gov.in/formate-documents-be-submitted-ministry-release-repertory-grant.</u> Separate filled Excel Sheets have to be submitted for each grant year i.e. 2021-22 and 2022-23.

3. All grantee organizations are also requested to submit duly-signed Pending Utilization Certificates of the previous grants, if any, received from this Ministry under any scheme/scheme component of Kala Sanskriti Vikas Yojana (KSVY).

4. All grantee organizations approved under Renewal category of Guru-Shishya Parampara (Repertory Grant) are requested to take necessary action and submit requisite documents as mentioned above and send the same through email on **<u>parts1-culture@nic.in</u>** on urgent basis to enable this Ministry to initiate action for releasing of approved grants.
