Minutes of the meeting of Steering Committee held on 22.10.2018 under the scheme component of 'Financial Assistance to Cultural Organizations with National Presence' under "Scheme of Financial Assistance for Promotion of Art & Culture" for the year 2018-2019.

A meeting of the Steering Committee was held on 22.10.2018 at 11:00 AM under the Chairpersonship of Shri P.L. Sahu, Joint Secretary(P.Arts) at Puratatva Bhawan, INA, New Delhi to examine the proposals in detail and to decide the quantum of financial assistance to deserving organizations under the scheme component of 'Financial Assistance to Cultural Organizations with National Presence' under "Scheme of Financial Assistance for Promotion of Art & Culture" for the year 2018-19. The following officials attended the meeting:-

- (i) Shri P.L.Sahu, Joint Secretary(P.Arts), Ministry of Culture;
- (ii) Dr. (Smt.) Rita Swami Choudhary, Secretary, Sangeet Natak Akademi; and
- (iii) Shri Suresh Sharma, Director-in-charge, National School of Drama.

2. At the outset the Chairperson of the Steering Committee i.e. JS(P.Arts) welcomed all the members of the Committee and gave a brief outline of the Scheme component, eligibility criteria and its relevant guidelines.


3. The Committee then examined the proposals submitted by the organizations after taking into account the profile of the organisation, subject of proposed project, duration of the project, estimated cost of the project and amount sought from the Ministry, expenditure done by the organisation/trust on cultural activities during three years out of the last five years and activities undertaken by the organisation. Analysis and recommendations of the Committee are as per Annexure.

4. While deciding the financial assistance to the eligible organizations, inter-alia, the following criteria have been mainly considered by the Committee:-

- (a) The organisation has spent Rs.1 crore or more during three of the last five years on cultural activities.
- (b) Geographical spread of the organizations keeping in view PMOs direction.
- (c) The organisation has capacity to do at least 20 events/programmes in a year.

5. The Committee has recommended the financial assistance to the under-mentioned organizations as per details given below, subject to the condition that the organizations will recognize the assistance being provided by the Ministry by appropriately displaying the name of Ministry of Culture as co-partner of the event/programmes through various means such as banners, posters, invitation cards etc. Further, photographs /videos will be uploaded by the organizations on social media sites of the Ministry for public feedback:-
