4. The expenditure involved is debit to the Demand No. 18- Ministry of Culture Art & Culture Major Head '2205' – Art & Culture - Minor Head 00.102 – Schemes and Mission- 11.01- Kala Sanskriti Vikas Yojna- Financial Assistance for the Development of Buddhist/Tibetan Culture & Art- 11.01.31 –Grant-in-aid General 2017-18 (Non-Recurring)

5. The grantee institution is situated in Accounts Circle of A.G.s of the concerned states and a copy of this letter is being sent to them.

6. The grant is non-recurring in nature and it is being released after fulfilling the conditions prescribed in GFR.

7. No Utilization Certificate and unspent balance of earlier grant is pending.

8. It is certified that the pattern of assistance under the Scheme of Financial Assistance for the development of Buddhist/Tibetan Culture & Art has the approval of the Ministry of Finance, Government of India and that this sanction is being issued in conformity with the rules and principles of the Scheme as approved by the Ministry of Finance.

- xiii) The organization will not obtain grant for the same purpose/project from any other source, indicating Government sources. In case, it receives grant for the same project from other sources also, the same will be intimated to Ministry of Culture immediately after receipt with proper reference.
- xiv) That if the Government is not satisfied with the progress of the project or considers that the guidelines of the scheme, terms & conditions of the sanction, etc are being violated, it reserves the right to terminate the Grant-in-aid with immediate effect and also take such other actions as it deems fit with or without prior notice.
- xv) The organization shall appropriately display the boards that should be erected at the project site indicating that the organisation is running under the aegis of Ministry of Culture, Government of India.
