The expenditure is debitable under this Head i.e Demand No. 18- Ministry of Culture- Art & Culture Major Head '2205'' Art & Culture Minor Head- 00.796 promotion of art & Culture- 32 Kala Sanskriti Vikas Yojna- 32.01 Schemes and Mission- 32.01.31 Scheduled Tribal Sub Plan 2018-19 (Non-Recurring).
- 5. The grantee institution is situated in Accounts Circle of A.G of the concerned states and a copy of this letter is being sent to them.
- 6. The grant is non-recurring in nature and it is being released after fulfilling the conditions prescribed in GFR.
- 7. No Utilization Certificate and unspent balance of earlier grant is pending.
- 8. It is certified that the pattern of assistance under the Scheme of Financial Assistance for the development of Himalayan Arts has the approval of the Ministry of Finance, Government of India and that this sanction is being issued in conformity with the rules and principles of the Scheme as approved by the Ministry of Finance.

 - e. The Audio-Visual documentation is to be done in HD form.
 - vii) The UC should also disclose whether the specified quantified and qualitative targets that should have been reached against the amount utilized were in fact reached and if not the reasons therefore.
 - viii) Unspent balance, if any to be surrendered to the Govt. without any delay.
 - ix) The grantee organization shall organize two activities (viz functions, lecture, seminar, workshop, exhibition training etc.) in any of the school in their vicinity. A certificate from the Principal of the concerned school would be a mandatory requirement for release of 2nd installment. In case of Cultural Shows, the number of artists participated may also be mentioned in the certificate.
