Subject: Minutes of the meeting of Expert Committee on Performing Arts Grant Scheme held during 11-15th May, 2015 for the year 2014-15-Issue of addendum and clarification regarding.

The meeting of the Expert Committee on Performing Arts Grant Scheme for the year 2014-15 was held during 11-15th May, 2015 in NSD, New Delhi and after approval of the Competent Authority the minutes of the meeting were uploaded on the official website of the Ministry. The recommendations made by the Expert Committee were indicated under ten different categories (Part A to Part J) in the minutes.

2. It has been considered necessary to issue clarification with respect to the statement made in the remarks column of the minutes as certain doubts have been raised by the grantee organizations. After considering the matter, the following clarifications are issued for all concerned:-

These cases shall be considered as continuing cases for the year 2015-16 and their grant shall be released accordingly after mandatory physical inspection. Further, applicant falling under this category will not be required to apply afresh for Salary Grant for 2015-16.
