Subject: Implementation of revised procedure of flow of funds under Central Sector Scheme through CNA – opening of fresh Zero Balance Subsidiary account under different CN A regarding

With reference to the above mentioned subject and in continuation to this Ministry's Circular dated 29th March 2023 in the website of Ministry of Culture regarding opening of zero balance subsidiary account for receiving funds under Scheme of 'Guru Shishya Parampara (Repertory Grant), all Organizations who are sanctioned grant under different sub-schemes apart from Guru Shishya Parampara (Repertory Grant) Scheme under Kala Sanskriti Vikas Yojana (KSVY) have to now open fresh Zero Balance Subsidiary Accounts in Canara Bank to receive funds under these Schemes. The procedure to be followed is as given below :-

(i) For receiving fund under any Scheme of KSVY apart from Guru Shishya Parampara (Repertory Grant), a second / third zero balance subsidiary account is required to be opened in Canara Bank by the organisation (known as Child agency).

(ii) The new bank details are to be submitted for registration of child agency to the respective C NA only.

(iii) The C NA will register the agency afresh in PFMS under KSVY and a new Unique ID will be provided for that Scheme. The name of agency will be shown in as **'(name of organisation_2'** for eg. **'xyz_2'** indicating that this is 2nd time registration of same agency in PFMS.

(iv) Once the Scheme (KSVY) is mapped to new bank account by the respective CNA, as and when funds are released by the Ministry for that Scheme, drawing limit will be set agency wise by the CNA. Thereafter, the agencies may draw the fund from CNA Account by raising payment advice from their respective new zero balance subsidiary accounts.

(v) Those organizations receiving grant under only one component of KSVY are required to open a Zero Balanced Subsidiary Account (ZBSA) in any branch of Canara Bank and inform the details of ZBSA to the concerned CNA (Scheme-wise CNA list attached). Upon receipt of ZBSA from the grantee organizations, CNA will register/map the bank details and give PD approval for further processing.

(v) For those grantee organizations who are sanctioned grant for the first time under KSVY, the ZBA account details may be submitted to the funding agency i.e concerned CNA(PD Level).

All Grantee organisations awaiting 1st instalment of grant sanctioned under Schemes in KSVY other than 'Guru Shishya Parampara[Repertory Grant] may therefore take necessary steps to open new ZBA accounts in Canara Bank urgently and submit the details to their respective CNAs.
