GENERAL TERMS & CONDITIONS

- 1. The successful bidder is required to furnish performance Security Deposit of Rs.75,000/- (Seventy five thousand only) in favour of DDO, Ministry of Culture, Government of India, New Delhi which should remain valid for a period of sixty days beyond the date of completion of all contractual obligations of the bidder including warranty obligations, if any.
- 2. The Security Deposit shall be forfeited in case (i) the contractor withdraws or amends its tender or increases its rates after opening the tender but before the validity of the quotations expire. (ii) Or refusal to enter into contract after award of contract.
- 3. The security deposit will be refunded on successful completion of the contract. No interest is payable on the security deposit.
- 4. Special Cell, Ministry of Culture shall not be bound to accept the lowest bid or any tender and reserves to itself the right to accept or reject any bid or to accept whole or a portion of tender as it may deem fit without assigning any reasons thereof and without incurring any liability to the affected bidders for the action of Special Cell, Ministry of Culture.
- 5. Bill is to be submitted triplicate duly pre-receipted to the Section Officer, Special Cell, Ministry of Culture, Vigyan Bhawan Annexe, New Delhi for payment.
- 6. Contractor shall in no case lease/transfer/sublet/appoint care taker for services.
- 7. No other person except Contractor's authorized representative shall be allowed to enter Special Cell, Ministry of Culture in Vigyan Bhawan premises.

- 14. The agencies/Contractors should attach the authentic documents with the Bid ensuring their capacity to co-ordinate and supervise the assignment as well as deliver high quality products maintaining a tight work schedule. The agencies should also clearly indicate the knowledge/experience of organizing event related works in the venues namely, Vigyan Bhawan/Vigyan Bhawan Annexe, National Museum, Nehru Memorial Museum and Library (NMML), IGNCA and Rashtrapati Bhawan.
